Health Guarantee

1. Buyer must have the puppy examined by a licensed veterinarian within 72 hours of receipt in order for this guarantee to be effective. If the puppy fails that exam by a licensed Veterinarian due to a condition existing at the time of sale, Buyer may return the puppy to Seller at the Buyer's expense for a refund of the purchase price only. Refunds will not exceed the original purchase price. Registration papers must be returned with the puppy.
2. Seller states that the puppy has been vet checked, dewormed, and has received age-appropriate vaccinations and care. Seller will provide available medical records to buyer.
3. Seller is not responsible for veterinary costs not approved in advance and in writing. Seller is not responsible for illness, injury, disorder, or death caused by Buyer's negligence, accident, improper care, stress, exposure, unsafe environment, poor nutrition, or failure to follow veterinary instructions. Seller is also not responsible for parasites or common puppy conditions, including worms, coccidia, giardia, kennel cough, fleas, mites, diarrhea, dehydration, hypoglycemia, minor umbilical hernias, innocent heart murmurs, cryptorchidism, uneven bite development, or other conditions that are temporary, curable, cosmetic, or commonly outgrown.
4. If, within the first year of life, the puppy develops a life-threatening hereditary or congenital condition, Seller may, at Seller's discretion, offer a replacement puppy of the same sex and comparable value when available. No cash refund will be provided unless Seller agrees in writing. Should death occur within 1 year of life due to suspected congenital or hereditary condition, Buyer must provide Seller with a written veterinary diagnosis and necropsy report, if applicable, before any replacement is considered.

Additional Terms

Buyer Responsibilities

Buyer agrees to provide fresh water, proper food, safe shelter, supervision, prompt veterinary care, parasite prevention, and age-appropriate vaccinations and deworming. Buyer agrees to make any diet changes gradually, avoid overexertion or rough handling, and seek veterinary care

immediately if the puppy shows signs of illness or distress. Failure to provide proper care may void this guarantee.

Breeding Rights _____ (Initial)

All puppies are sold with limited AKC registration and no breeding rights unless breeding rights are purchased separately for an additional \$500. Seller will not guarantee the fertility, breeding soundness, or reproductive ability of any puppy. Breeding rights purchased? Yes / No

No Guarantee on Performance/Appearance _____ (Initial)

Seller makes no guarantee as to temperament, training, or working ability. Basic obedience, socialization, and all training are the responsibility of the Buyer. Seller makes no guarantee regarding coat color, coat quality, coat length, adult size, ear set, or eye color at maturity. Seller does not guarantee the accuracy of any genetic testing performed on the parents and shall not be responsible for any laboratory error or discrepancy. Seller makes no guarantee that the puppy will pass any current or future genetic testing.

Agreement Terms _____ (Initial)

This is the entire agreement between the parties and may not be changed except in writing signed by both Buyer and Seller. Any violation of this agreement may void Seller's guarantee. If Buyer relinquishes ownership of the puppy for any reason, this contract becomes null and void.

This Agreement shall be governed by and construed in accordance with the laws of the State of Alabama, without regard to conflict-of-law principles. Any dispute arising out of or relating to this Agreement shall be brought exclusively in the county of Seller's residence, and Buyer knowingly and voluntarily consents to the jurisdiction and venue of that court to the fullest extent permitted by law. For internet, remote, and out-of-state sales, Buyer expressly agrees that Alabama law and Seller's chosen venue shall control except where applicable law requires otherwise.
